

For an idea of how our local businesses are changing for the benefit of the community, check out the below and go Shop. Eat. Spend. Enjoy. Support Local.

Many of our businesses and grocery stores now offer curbside pickup or delivery, while dine-in or drive-thru only restaurants added food delivery as an alternative for their hungry customers not always being able to leave their home (thank you Door Dash and Instacart!).

Effing Brew Company and Gopher's Grill created permanent outdoor seating as part of the Jefferson St. renovation. Niemerg's Steakhouse built a drivethru to safely social distance while distributing meals (and groceries) for its patrons. Top Shelf is near completion on its new location on Mid-America Ave. offering drive-thru service. Domino's built a larger building with a dine-in and a drive-thru on Fayette Ave. Fox Holler renovated a previous building to provide a second drive-thru location on the south-side of Effingham (woo hoo!).

CEFS Head Start 0-5 Program relocated to the old Helen Matthes Library for a larger space, and Montessori Kids Universe opened within the Agracel building to fully accommodate growing childcare needs within the county. Al Liquors opened its second location in Effingham on Hwy 33 which offers Lake

Sara and the west side of the county a bourbon bar, humidor, live entertainment, and delicious barbecue provided by Lickin' My Chicken and Pullin' My Pork food truck. Broughton Tattoo & Vagabond Eatery added their businesses to the Amtrak Station building.

The Village of Dieterich is prospering like crazy with the Dieterich Community Center, new streets (Corporate, Commerce & Prospect) for the industrial park, and an enhanced downtown area. Read more detail about the growth and plans for Dieterich on page 12.

Other businesses who are adding to the landscape and revenue of the county are: Village of Teutopolis opened their new building after demolishing the old in late 2020; Don Pedro moved downtown from Fayette Ave.; Continental Mills moved into the former Hodgson Mill facility; Hetzel's Overland Transport built new on South Banker; I70 Truck Center built a new facility along Hwy 45; Sarah Bush Medical Offices constructed a two-story building to replace Bonutti Clinic and offer more services; Dollar General now occupies the old Family Video building on Fayette Ave.; and Homewood Grill remodeled and opened a second location on Banker St. in front of the Village Square Mall.

Not only does Effingham County have current businesses expanding, but we also welcomed ProRehab; Golden Corral; Flex-N-Gate; Boho Chic Clinique; The Exchange; Bobcat of Effingham; and Canarm to name a few new businesses.

Along with new or changing businesses, travel to town has increased with many residents offering their home (or building new) for vacation rentals. This is a growing industry in many larger cities, so it seems fitting as an amenity for Effingham. Lake Sara, Teutopolis and the

ECONOMIC DEVELOPMENT UPDATE

The City of Effingham announced it is being awarded grant funds of \$1,464,019 for a street expansion along with water and sewer improvements to Thies Avenue, and for street Improvements and a sewer expansion along Airport Road through a joint application with Effingham County. The City of Effingham is only 1 of 11 new projects that will unlock a total investment of \$75.5 million, while creating at least 1,465 jobs statewide with the Rebuild Illinois Funded Regional Economic Development (RIRED) Grant fund throughout the State of Illinois.

The grant will provide for an extension of Thies Avenue along with water and sewer extensions for an expansion of **John Boos & Company.** Thies Avenue will be extended westerly and then northerly providing much needed access for the project. The street extension also provides access to adjacent industrial property which the city recently purchased for future economic growth.

Additional grant funds of \$310,000 acquired by the City and County through the Economic Development Program (EDP) will assist with the match for this project allowing it to be completed with almost zero local tax dollars.





The Equity Fulfillment Center located off Merchant Street facing Temple Avenue is expected to complete in November 2021. When finished, the Fulfillment Center will be connected to The Equity Farm & Home Store. Customers will be able to pick up online orders, curbside pickups, and bagged feed and seed by pulling under the awning and an Equity Farm & Home Store Team Member will load your order for you.





The Village of Dieterich is excited for construction to be nearly complete on the future Corporate, Commerce and Prospect Streets, along with two new intersections at IL Rt. 33, to provide access to our new Dieterich Industrial Park East. This new industrial park will consist of 23 lots ranging from 0.82 acres to 7.43 acres that are shovel ready for commercial and light industrial use. Construction is anticipated to be complete November 2021 and lots are on sale now! Every lot will have access to underground Ameren 3-phase electric, natural gas, water, sanitary sewer, storm sewer and fiber optic lines with

covenants in place to regulate construction and protect property values. These new lots, and the businesses to be developed, will be a spark to the Dieterich Community and Effingham County. They are eager for the completion of these new streets and look forward to welcoming new and expanding businesses. Thanks to many partners in this process, they are thrilled to be able to continue the progressive economic development Dieterich has been known for the last 20 years.



The ITEP 2016 Dieterich Downtown Enhancement Project is part of a larger plan to enhance Dieterich's vital economic downtown area and create a better quality of life for all residents by addressing numerous ADA safety issues. This project will improve the ability of pedestrians to travel to and from the park, school, downtown and residential areas more safely and efficiently. Adding ADA accessible sidewalks, crosswalks and pedestrian lighting on portions of W. Section, Pine, Park and Church Streets will enable safer travel for all. This project will create a unified look to a busy portion of downtown Dieterich. Connecting this project to previous downtown sidewalk additions will complete the missing link for needed safety and aesthetic upgrades. This project is the fifth phase of a long term plan to improve the quality of life for Dieterich residents by removing old existing non-ADA compliant sidewalks and constructing a new continuous network of concrete sidewalks and crosswalks that are ADA compliant and aesthetically pleasing with decorative stamped concrete boulevards. New concrete curb and gutters will be installed along with improved storm sewers. Decorative pedestrian lighting will be installed throughout the project area and encourage safe walking during the evening hours. A new much-needed dedicated pick up and drop off lane will be constructed on Pine Street at the entrance to the Dieterich Elementary School to safely allow for children to enter and exit the school.






