AUTHORIZATION:

The “Customer” hereby authorizes the local Energy Distribution Company (EDC) to permit the authorized “Licensed Electricity and or Natural Gas Service Supplier” to directly receive “Customers” most recent twenty-four (24) months account data and twelve (12) months of payment history for the Account Numbers with meters located at the address shown on ATTACHMENT A. The authorized “Licensed Service Supplier” has the right to use the information provided and to retain the information in its files, and disclose it to any authorized employee, agent, or representative. The authorized “Licensed Service Supplier” hereby agrees not to sell or otherwise disclose said information to any third party not authorized in writing by “Customer”.

“Customer” hereby authorizes “Licensed Service Supplier” to process this Authorization for credit review and approval. All information provided will be held in strict confidence and used only by “Licensed Service Supplier” or its affiliates, in making its credit evaluation.

"Customer" hereby authorizes and designates CQI Associates, LLC as the authorized representative for the management of Customer's electricity and or natural gas distribution, supply services, and related procurement and account enrollment services as directed by the "Customer". This authorization in no way binds "Customer" to the purchase of a supply services and is to be used for the sole purpose of determining an offer price and selecting a supplier for the requested supply services.

"Customer" hereby authorizes the "Licensed Service Supplier" to deal with CQI Associates, LLC representatives on matters pertaining to the collection of data and to receive pricing and invoicing information as it pertains to "Customers" designated electricity and or natural gas procurement information as authorized herein, in order for CQI Associates, LLC to evaluate the pricing requests.

"Customer" grants CQI Associates LLC an "exclusive authorization" as the "Customers" representative to purchase the designated electricity or natural gas supply services. The authorization is intended to comply with the provisions of the laws and regulations of the state of incorporation and public utility regulatory commission. The authorization and services to be performed by CQI will remain in effect for 180 days from the date of "Customers" representative signature below. Continuation of services thereafter will require a new authorization. "Customer" may rescind this authorization at any time by providing notice to us by email.

CQI Associates, LLC is licensed as a buyer's consultant/broker by the State Public Service and/or Utility Commission. The applicable CQI Associates, LLC professional service fees will be paid by the selected supplier based on the supply services consumed during the term of the contract.
